#### **Not included:**

##### **Return flight to Hurghada International airport**

Supervision for PADI Scuba Diver, CMAS 1\* or equivalent, or any level with less than 20 logged dives: 6 € per person and per dive.

Dive gear – available for renting on request.

Hotel extra for single room.

Drinks and other extras at the hotel.

Crew tip: at your own discretion (normally 2 € to 3 € per day).

#### **Mandatory:**

Medical certification or statement authorizing scuba-diving (less than 1 year old).

Personal insurance covering the risks related to recreational scuba-diving.

For certified divers, diving certification card and logbook stating the number of dives and the last dive performed.

**Diving will not be permitted if any of the above documents cannot be presented.**

## **GENERAL TERMS & CONDITIONS**

### **Booking policy**

All bookings have to be made through one of our approved Travel Agent, who will be solely responsible of the booking.

### **Payment policy**

All bookings will be confirmed after receiving a deposit of 25% of the required amount on one of the bank accounts of the United-Divers Safaga company.

**The balance of the booking needs to be paid at the maximum 15 days prior to arrival.**

### **Cancellation policy**

- 60 days prior to arrival	25%	of the total amount
- 30 to 59 days prior to arrival	50%	“
- Less than 30 days prior to arrival	100%	“

United-Divers Safaga may cancel the booking 30 days prior to the date of arrival, for any reason beyond its control.

In case United-Divers Safaga should cancel the booking within 30 days of the arrival, an alternative solution will be offered to the guests.

If the guests refuses the alternative offer, United-Divers Safaga will refund to the guest all the sums paid towards diving packages and courses only. The alternative offer being declined, United-Divers Safaga will not be liable for any other costs such as compensation, cancellation fee for flight tickets or the loss of flight tickets.

### **Diving**

The boats offered by United-Divers Safaga are subject to change without notice. If for any reason beyond its control the planned boat was not available, an equivalent or higher-class boat will be offered as a substitute. All dives are subject to change according to weather conditions and Egyptian Government approval. Whilst all efforts are being made to meet the planned itinerary, diving at specific sites is not guaranteed. The dive guides and captain of the boat will have the final decision on the dive sites in order not to compromise in any way the safety of the guests, the staff and the boat. In the unfortunate event that a planned dived should be modified or cancelled, United-Divers Safaga will do its best to postpone the dive, but will not offer any refund or compensation.

The dive sites described on the web site [www.united-divers-safaga.net](http://www.united-divers-safaga.net) are subject to change and depend on the weather conditions, safety conditions and Egyptian Government approval.

### **Contract acceptance & jurisdiction**
